Sir/ Madam,

I am directed to convey that all medical colleges/Institutes having valid Letter of Permission (LoP) for MBBS admission are required to fill the details/data of respective Institutions on NMC portal for Annual Declaration as required in the NMC Act, 2019 and various regulations. Accordingly, through Public notices, all colleges/Institutions were directed to submit the details on the portal. Details submitted by your college have been assessed by the experts and few deficiencies were noted. Your college was also issued a show cause notice dated 17.01.2024 earlier containing the details of deficiencies observed by UGMEB with respect to AEBAS.

2 Vide the above show cause notice issued to your college, it was directed to furnish the reply regarding each of the points raised in the show cause notice within fifteen days (15 days) and give an explanation as to why the action should not be initiated against your college as per the regulations since your college has not fulfilled the provisions laid down under NMC Act 2019 and



other various guidelines, regulation notified by NMC. Here, it is pertinent to reiterate that all the medical colleges were earlier continuously intimated in the form of circulars/public notices uploaded through NMC website and show cause notices stating to take necessary action to fulfill the provisions laid in various regulations and guidelines by NMC.

3. In view of the recommendations of experts made on Annual Declaration of your college, taking a lenient view, the Undergraduate Medical Education Board have decided to grant Renewal of **250 seats** for MBBS for the year 2024-25 subject to fulfillment all clauses mandated in National Medical Commission Act, 2019 and various other Regulations notified from time to time.

4. It is further informed that the re-assessment of your college may be carried out at any point of time and if any deficiencies found with your college, stringent action as mandated under MSMER-2023 Chapter-III clause-8 under the heading penalties shall be imposed.
