ORDER (Date: 12th July, 2019)

- 1. This appeal is filed under Sec. 10 of Madhya Pradesh Niji Vyavasayik Shikshan Sanstha (Pravesh Ka Viniyaman Avam Shulk ka Nirdharan), Adhiniyam, 2007 (hereinafter referred to as "Act of 2007") against the order passed the Admission and Fee Regulatory Committee (AFRC for short) dated 08/07/2019, whereby the fee for the appellant institute was fixed at Rs.9,28,000/- per student per year for MBBS Course run by it for academic sessions 2019-20, 2020-21 & 2021-22.
- 2. This appeal is filed on ground that the AFRC has fixed fee of the appellant institution at Rs.9,28,000/-. No enhancement was made by AFRC from last year's fees. The institute has received NABH accreditation. However, benefit of this accreditation has not been given to the appellant institution by AFRC. The appellant further submits that appellant institution is a new institution. This year additional students will be admitted which will entail additional expenditure due to increase of number of students. This fact was not taken into consideration by the AFRC. During the course of argument, the appellant submitted that looking to fact that the appellant is a new

institutions. Till the last years, 4% additional weightage was given to institutions for NABH accreditation and 3% for NACL accreditation. This additional weightage is in line with provisions of clause (vii), sub section (1), of section 9 Act, 2007 which provides that any other relevant factor should also be taken into consideration and such accreditation is a relevant factor to be taken into consideration, while fixing fees. Denial of this weightage by AFRC is certainly against the rules, and therefore, the impugned order passed by AFRC is liable to be set aside. On this aspect the appeal deserves to be allowed.

- 6. During the arguments, the fee was calculated afresh by Shri Daga and after due consideration, it was found that after taking into account, the fee to be paid by additional students @ Rs.9,28,000/- per year per student. It would be sufficient to cover atleast part of the additional expenditure, if any, incurred by the appellant institution. Accordingly, here it appears to be no change so far as the basic fee is concerned. This apart, the revenue will be further enhanced after adding 4% amount for NABH accreditation as allowed in previous para.
- 7. Accordingly, this appeal is partly allowed. So far the NABH accreditation is concerned, this appeal is allowed and order passed by AFRC is partly modified. After adding this benefit, the fee is calculated as under

Round off to Rs.9,65,000/-(Rupees Nine lakhs sixty five thousand only).

- 8. Accordingly the fee is fixed at Rs.9,65,000/-(Rupees Nine lakhs sixty five thousand only).
- 9. The AFRC has fixed fee for three academic sessions' i.e.2019-20, 2020-21 and 2021-22. As stated earlier, the appellant institution is a new institution imparting medical education and each year fresh batch of students will be admitted. Taking this peculiar circumstance into account, the fees fixed by AFRC for academic session 2020-21, 2021-22 is set aside. The fee is fixed only for academic session 2019-20. The appellant shall be at liberty to approach the AFRC next year with fresh financial data.
- 10. The appeal is disposed off accordingly.
